Sun Protection Policy

PURPOSE

The purpose of this policy is to support sun protection behaviours at Warragul North Primary School to minimise risk of health problems from sun overexposure, including skin cancer.

This policy provides guidelines to:

- support staff and students to use a combination of sun protection measures when UV index levels are 3 or above (generally mid-August to the end of April in Victoria)
- ensure that there are outdoor environments that provide adequate shade for students and staff
- ensure students are encouraged and supported to develop independent sun protection skills to help them to be responsible for their own protection
- support our school's strategies to meet its duty of care and occupational health and safety obligations to minimise harmful UV exposure and associated harm for students and staff.

SCOPE

This policy applies to all school activities on and off-site, including camps and excursions. It is applicable to all students and staff.

POLICY

Overexposure to the sun's ultraviolet (UV) radiation can cause health problems including sunburn, damage to skin and eyes, and an increased risk of skin cancer. UV damage accumulated during childhood and adolescence is strongly associated with an increased risk of skin cancer later in life.

UV radiation:

- cannot be seen or felt
- can be reflected off surfaces such as buildings, asphalt, concrete, water, sand and snow
- can pass through light clouds
- varies in intensity across the day and the year (highest from mid-August to the end of April in Victoria)
- peaks during school hours.

Sun safety is a shared responsibility and staff, parents and students are encouraged to implement a combination of sun protection measures whenever UV levels reach 3 or above. Information about the

daily local sun protection times is available via the SunSmart widget on the school's website/intranet, the free SunSmart app, or at sunsmart.com.au or bom.gov.au.

Warragul North Primary School has the following measures in place for all outdoor activities during the daily sun protection times to help reduce the risk of over-exposure to UV radiation for staff and students.

Shade

Warragul North Primary School provides sufficient options for shelter and trees to provide shade on school grounds, particularly in places such as:

- where students congregate for lunch
- the canteen
- outdoor lesson areas
- popular play areas
- assembly areas

Students are encouraged to use available areas of shade when outdoors during peak sun protection times, particularly if they do not have appropriate hats or outdoor clothing. Students receive regular reminders to access shade spaces to reduce their exposure to the sun.

When building works or grounds maintenance is conducted at Warragul North Primary School that may impact on the level of shade available to staff and students, a review of the shaded areas available will be conducted and further shading installed as appropriate.

In the event that the UV rating becomes extremely high or as a result of inclement weather including extreme heat, a hot day timetable will be called and students will be supported with opportunities for inside play. Warragul North Primary School will continue to develop outdoor areas that have adequate shade for outdoor play and learning.

Sun protective uniform/clothing

Warragul North Primary School's uniform includes sun-protective clothing, including:

- Hat that covers ears and face
- loose, cool, densely woven fabric
- shirts with a collar and/or high necklines
- tops with elbow length or long sleeves
- longer style shorts, dresses, and skirts
- rash vests or t-shirts for outdoor swimming activities.

Warragul North Primary School's uniform applies on and off-site unless otherwise advised. When students are not required to wear school uniform (such as school camps, free dress day), Warragul North Primary School will ensure steps are taken to encourage students to wear sun-protective clothing whenever UV levels reach 3 and above.

Hats

From mid-August (exact date to be set by the school annually) to 30 April, all students **must** wear a sun protective hat that shades the face, neck, and ears for all outdoor activities. To support students to be SunSmart, the school will:

- Ask students to put on hats and leave them on during their time spend outdoors
- Remind students with or without hats to access or remain in shade spaced to reduce their exposure to the sun. Hats may also be worn for all outdoor activities outside of the August to April time period, by parent or student choice
- Provide spare hats wherever possible for students to borrow. The school will wash them so they are ready for re-borrowing
- Prompt students to drink water during their recesses and lunchtimes
- Encourage students to seek a staff member if they don't have a hat
- Send reminders to parents if a child is without a hat.

Students wear a school hat or a hat that protects the face, head, neck and ears when outdoors, for example broad-brimmed, legionnaire or bucket hat.

Baseball or peaked caps and sun visors are not considered a suitable alternative, as they do not protect the ears, cheeks or neck.

Students who are not wearing appropriate protective clothing or hats will be encouraged to use available areas of shade when outdoors or a suitable area protected from the sun.

Sunscreen

Warragul North Primary School encourages all staff and students to apply SPF50 broad-spectrum, water-resistant sunscreen daily whenever UV levels reach 3 and above. Sunscreen should be applied at least 20 minutes before going outdoors and reapplied every two hours (or more frequently if sweating or swimming).

At Warragul North Primary School, if students do not have their own sunscreen, they can use the sunscreen provided in classrooms.

Staff and students who may suffer from skin reactions from certain types of sunscreen are encouraged to contact the First Aid officer or a member of leadership on (03) 5623 4066 to implement a plan to reduce the risk of a sunscreen reaction at school. Families can send their child to school with a suitable alternative sunscreen. The school will send a photo of the school sunscreen brand to families.

Curriculum

Students at our school are encouraged to make healthy choices. They are supported to understand effects of sun exposure and are encouraged to be involved in initiatives to promote and model sun protection measures to the whole school. Warragul North Primary School will address sun protection and UV safety education as part of Health and Physical Education lessons.

Staff role-modelling and OHS

When outdoors, staff are encouraged to wear suitable SunSmart clothing and hats during the period August to the end of April. Staff are encouraged to access resources, tools, and professional learning to enhance their knowledge and capacity to promote sun smart behaviour across the school community.

UV radiation exposure is considered as part of our school’s risk management and assessment for all outdoor events and activities, i.e. UV radiation protection strategies are included in school camp activities, excursions, sports days and interschool sports events.

Families and visitors

Families and visitors participating in and attending outdoor school activities are encouraged to:

- wear a sun-protective hat, covering clothing and, if practical, sunglasses;
- apply SPF30 (or higher) broad-spectrum, water-resistant sunscreen; and
- seek shade whenever possible when outdoors.

Community engagement

Sun protection behaviour is regularly reinforced and promoted to the whole school community through newsletters, school website/intranet, staff and parent meetings, school assemblies, student and teacher activities and at student enrolment/new staff orientation.

Families, students and staff are provided with information, ideas and practical strategies to support UV safety at school and at home. Warragul North Primary School may provide information through newsletters, on the school website or at school assemblies.
